1. All members of the Port Angeles USBC Bowling Association are eligible to bowl in this tournament. USBC members living within the jurisdiction of this association, who are not members of another association, may enter by paying an affiliate membership fee of \$8.00. Board may evaluate any eligibility issues.
2. Events to be held are : Singles, Doubles, Team, Handicap All-Events, and Scratch All-Events, per division.
3. Team events may be bowled up to 3 times, provided 2 or more members are changed per Team event.
4. A bowler can bowl only once in Singles, and up to 3 times in Doubles, provided 1 member is changed per Doubles event.
5. Handicap All-Events and/or Scratch All-Events are optional with paid fee of \$5.00 per event. Bowlers that participate in more than one Team or Doubles event will use their first event scores to calculate their All-Events score.
6. Averages used will be the highest sanctioned 2016/2017 winter league average of 21 or more games. If no winter average, use highest 2016/2017 summer average of 21 games or more. If no 2016/2017 average has been established, the bowler will then use January 1, 2018 highest league average of 21 or more games. If no other average has been established, the bowler must bowl scratch, using an average of 220 for men and 200 for women.
7. All paragraphs and subparagraphs of USBC Rule 319A, B, & C will apply to the assignment of averages (rerates and adjustments) for this tournament.
8. Divisions will be set up as follows:

9. The prize ratio will be at least 1 in every 6 entries for Singles, Doubles, and Team events; at least 1 in every 10 for Handicap All-Events and Scratch All-Events.
10. Bowlers must verify, by signing recap sheets, their own scores. Submitted recap sheets are FINAL.
11. Itemized entry fee: \$21 per person, per event (\$13 bowling fee, \$7 prize fee, \$1 expense fee). Optional Handicap All-Events and Scratch All-Events are \$5.00 each.
12. All prizes and awards will be awarded on a handicap basis, except the optional Scratch All-Events.
13. All prize fees will be returned 100% to the event they are collected for.
14. Entries for Team Event will close 15 minutes prior to scheduled start time each day. Entries for Doubles/Singles Events will close 30 minutes after the Team Event scheduled start time each day.  
**There will be NO EXCEPTIONS.**
